# **Ohio High Court** Upholds Law Allowing Longer Time in Prison for Poor Behavior

• A law allowing prison officials to extend certain incarcerated people's time behind bars does not violate the state constitution, the Ohio Supreme Court ruled in a 5-2 decision Wednesday.

The 2019 law, challenged by two imprisoned men, lets Ohio's Department of Rehabilitation and Correction argue that the parole board should keep some felony offenders in prison past the minimums of their sentence ranges due to bad behavior or because there are signs they have not been rehabilitated.

The measure was named for Reagan Tokes, a college student abducted, raped and murdered by a man on parole in 2017.

Christopher Hacker, who is serving time for aggravated burglary, and Danan Simmons Jr., previously sentenced on weapon and drug charges, argued that the law violates the constitutionally outlined separation of powers between the judicial branch, which issues sentences, and the executive branch, which includes the prisons department.

# **DeKalb Jury Awards \$14M for Child's Death in Car Crash**

A FATHER-SON PLAINTIFFS' team has helped secure a \$14M win in a DeKalb County wrongful death trial for a 6-year-old boy.

Plaintiffs' attorney Bruce Hagen said the major challenge in the case was how to persuade the jury of the monetary value of a young person's life.

"We'd gone through focus groups, and everyone's reaction was the same: 'This is horrible, but how do you put a dollar value on it?" Hagen said. "We tried to focus the trial on the human loss."

According to the plaintiffs' outline of the events in the pre-trial order, Andrew Evans was visiting his grandmother on the day of the crash in July 2018. The driver, Shannon Hartsfield, an acquaintance of his grandmother, ran a stop sign and drove directly into the path of a Ford F-150. The truck collided with Hartsfield's sedan, killing all four passengers.

# **U.S. Judge Extends Deadline for Organizers Trying** to Stop 'Cop City' With Petition

A FEDERAL JUDGE on Thursday significantly extended the deadline for Atlanta organizers who have been trying to gather more than 70,000 signatures to force a vote on the construction of a police and firefighter training center that critics call " Cop City."

U.S. District Judge Mark Cohen ruled that the city had imposed an unlawful requirement that those collecting signatures have to be residents of Atlanta. A group of people who live in DeKalb County just outside the city had sued - saying they should be allowed to join in the canvassing effort and noting that the planned site for the training center itself is in unincorporated DeKalb County, outside the city limits.

"Requiring signature gatherers to be residents of the city imposes a severe burden on core political speech and does little to protect the city's interest in self-governance," Cohen wrote, adding: See COP CITY, page 5

# Parents' Suit **Alleges Teen Was** Sexually Abused at S.C. Therapeutic **Boarding School**

A TEENAGER WITH special needs was repeatedly sexually assaulted by an employee at a small private boarding school in South Carolina, his parents said in a lawsuit as they advocate for more oversight of similar therapeutic facilities.

The teen, who attended Whetstone Academy between October 2018 and January 2020, was "frequently sexually assaulted" and raped beginning when he was 14, the lawsuit said.

The lawsuit accuses Singleton Investment Properties, the school's parent company, of negligence and failure to reasonably protect the teenager. The company denies the allegations.

The parents are identified anonymously in the lawsuit filed in April as Mother Doe and Father See ABUSE SUIT, page 3

# **Businesses Can Maximize High Court's Latest Ruling on Arbitration Provisions**

THE U.S. SUPREME Court recently provided another win to businesses who seek to settle disputes in arbitration rather than litigation. The ruling in *Coinbase v. Bielski* on June 23 reflects a continuing statement that, as a matter of public policy, arbitration provisions are to be enforced, and that if a court is to err, it should generally err in favor of enforcing the arbitration provision. In fact, the justices arguably elevated arbitration provisions to a preferred plane over other contract provisions.

The ruling makes arbitration that much more attractive to large companies and many other businesses. They and their lawyers can view the decision as another tool to pause or avoid class actions and other types of expensive litigation in favor of arbitration. They should also use the decision as an opportunity to review the arbitration provisions in their contracts to maximize the value of arbitration.

# Analysis and Impact of the Ruling

The *Coinbase* case focused on the appeal of a federal district court's decision to deny arbitration. Federal law makes arbitration unusual in this regard: the Federal Arbitration Act (FAA) grants an immediate (or interlocutory) right to appeal if a court refuses to order arbitration.

In other contexts, businesses generally cannot appeal as a matter of right until the court has ruled on the overall case. Additionally, there is not an automatic right to appeal if the district court grants arbitration – the appeal option only benefits the party that wants to arbitrate.

What was not settled before the Supreme Court's ruling was whether the district court was required to halt all proceedings while that interlocutory appeal plays out. In a 5-4 decision, the justices ruled it is. Writing for the majority, Justice Brett Kavanaugh framed the decision in practical terms. He quoted from a precedent in saying it "makes no sense for trial to go forward while the court of appeals cogitates on whether there should be one."

The ruling will prevent inefficient use of judicial resources, as a successful appeal requiring arbitration could literally invalidate everything the trial court did while that appeal was pending. The dissent would leave the decision of whether to stay the case to the discretion of the trial court.

The majority decision was signed by justices who would generally define themselves as textualists. Yet they admit that there is nothing in the text of the relevant statute that justifies their decision. The dissent repeatedly draws attention to that fact. (This issue helps to explain the strange bedfellows of Justice Clarence Thomas joining most of the dissent with his colleagues who are considered more liberal.)

Nevertheless, the ruling is consistent with the past 15 or so years of Supreme Court jurisprudence on arbitration. Those decisions, by and large, have made it very difficult for a party to avoid an arbitration provision. This is the latest sign that the federal judiciary will go to great lengths to support a company's right to arbitrate.

It is also another step away from the general premise that arbitration agreements must be treated the same as any other contract provision. No other contract provision, to the best of our knowledge, has the kind of preferential treatment where an interlocutory appeal automatically stays the entire litigation. Having said that, the fact that the statute allows for an interlocutory appeal in and of itself puts an arbitration provision in an unusual statutory position.

The impact of the ruling will be significant. If a party with an arbitration provision is unable to convince a district court to enforce it, there is now almost a guarantee that they will appeal, and they can use that to put the case on hold.

The party that does not want to arbitrate would then have a Sophie's choice: wait for what could be a year or more while the appeal plays out or immediately begin arbitration. That choice clearly favors companies who prefer arbitration. More plaintiffs will look at those options and likely decide it's not worth fighting the appeal.

# A Potential Wrinkle in State Courts

There will be an interesting question as a result of the ruling tied to what happens in state courts. Due to federal preemption and certain advantages of the FAA, many defendants rely on the FAA even when moving for arbitration in state courts. Is the Supreme Court's required stay of arbitration pending appeal a substantive matter of law under the FAA or a procedural issue to be decided under state law? The answer to this question will have a significant impact on state court litigation and may be heavily litigated in the coming months and years. It is certainly an issue to be considered if a party is thinking of removing a state court action to federal court.

In the meantime, businesses that want the benefit of the stay during an interlocutory appeal should include language in their contracts that the FAA governs their disputes.

# Practical Advice to Make the Most of Arbitration

The fundamental draw of arbitration is that it can be faster and less expensive than litigation. But achieving those goals requires the attention of parties who want to arbitrate, starting with how they draft their arbitration agreements in the first place.

It is not uncommon for arbitration provisions to be "cookie cutter" and simply state that the parties must arbitrate their disputes. Drafted properly, however, a wellthought-out arbitration provision could conceivably run to several pages long. The specifics depend on each company's strategy, goals and risk tolerance, but here are a few things to consider:

- What should the size of the arbitration panel be? Some businesses prefer a panel of three arbitrators so that no one person can drive the decision. But that can result in impractically expensive arbitrations for small disputes. One option is to use a sliding scale in the contract, where the size of the dispute dictates the size of the panel.
- How much discovery will be allowed? If both sides conduct a lot of discovery, then arbitration costs are necessarily going to increase. It will also take longer to get a final decision. But it's important for business leaders and their attorneys to think through what level of discovery is needed to fairly adjudicate the types of disputes they typically have. Consider putting guardrails around discovery into the contract, such as by limiting the time period it will run.
- What rules should the company designate? Choosing to apply a particular provider's arbitration rules can have a significant impact on how the arbitration proceeds. One example we often discuss with clients is the level at which a provider will treat an arbitration as expedited. The amounts in controversy where a provider defaults to expedited rules can range from \$100,000 to \$3 million. Some parties may be uncomfortable submitting a multimillion-dollar dispute to an expedited process with limited to no discovery. In contrast, some businesses may find those rules fit their strategy and risk tolerance well. Choosing the rules that best fit your company's goals is therefore something that requires significant thought.

These are just a few of any number of issues a party may identify as worth including in an arbitration provision.

# **Final Takeaways**

Under the FAA, businesses have an absolute right to an immediate appeal if their request to compel arbitration is denied at the district court level. As a result of the Supreme Court's *Coinbase* ruling, they now also have a guarantee that the case will be stayed while the higher court considers the appeal. That's not just one but two great reasons to consider using arbitration to settle disputes.

Now is a good time for defendants to revisit the arbitration provisions in their contracts and ensure they provide the protections and process each business wants.

Doe and their son as John Doe. The Associated Press generally does not identify people who say they have been sexually abused and is not naming the parents to avoid revealing their son's identity.

The parents previously sued the school and in January reached a confidential settlement. But they said they hope to bring about broad change and accountability by going after the corporate structure in this subsequent suit.

The judge earlier this month indicated a trial would likely be held next spring, but has ordered the two sides to participate in mediation to see if a settlement can be reached before then.

"We're really hoping there's some systematic change, some legislation enacted and real accountability here," the Does' attorney, Tyler Bailey, told the AP.

Therapeutic boarding schools like Whetstone should be regulated similarly to state-licensed daycare centers, with complaints tracked and publicly accessible, to the extent possible, Bailey said.

"Money is one thing but change so parents and children don't go through what they have gone through, that's what they're seeking to get done by this case," Bailey said.

John Singleton Jr., who owns Singleton Investment Properties and Whetstone Academy, said in an email, "We specifically deny the allegations." The company also denied the allegations in a court filing earlier this month.

Once the school learned of the allegations from the South Carolina Department of Social Services, the employee was immediately suspended and the school fully cooperated with an investigation by the state agency. Since the agency took no action and no criminal investigation was undertaken or charges filed, the employee was reinstated and has returned to work at the school, Singleton said.

The employee is not named in the lawsuit.

"Whetstone Academy's focus was, is, and always will be on ensuring that every student is cared for in a safe and nurturing environment with close supervision and stringent staff oversight," Singleton wrote. "Students receive individual and family therapy by our licensed clinicians. We provide evidence-based training for our staff who are guided by our policies and procedures."

The Does, who live in Alabama, said their son was diagnosed with autism spectrum disorder when he was young. By age 14, he was having several outbursts a day, breaking things and emotionally troubled, the father said in a phone interview. An educational consultant suggested sending him to a therapeutic boarding school for extra care and therapy.

Whetstone Academy, in the remote Mountain Rest community in the northwest corner of South Carolina, takes students in grades five through nine and was one of the schools suggested by the consultant.

The teen initially seemed to be making progress at the school, but after about 10 months his behavior was so difficult that the parents were advised to send him to a different facility for more intensive treatment, the father said. After a summer in that facility, he returned to Whetstone.

"He stayed there for a little while, but he realized that if he acted out, he would get kicked out and he did," the mother said. "Thank God he did."

The Does then sent their son to a school in Utah. After about six months there, his parents flew him to a resort in Georgia for a vacation. At dinner one night, John Doe told his parents he had been sexually assaulted numerous times and raped by an employee at Whetstone, his mother said.

The Does called their son's therapist at the Utah school for advice. Bound by mandatory reporting requirements, the therapist contacted authorities, who interviewed the teenager and said they notified South Carolina authorities to investigate, the father said.

South Carolina's social services agency doesn't license therapeutic boarding schools, but spokesperson Connelly-Anne Ragley said in an email that the agency investigates upon receiving reports of sexual abuse involving minors. Any sexual abuse allegation sent to the agency's intake line would be reported to law enforcement within 24 hours as required by state law, she said.

The Department of Social Services told the AP that information about child abuse investigations is confidential and not releasable under the state's open records law.

The sheriff's office in Oconee County, where Whetstone is located, only conducts criminal investigations when an official report is filed and, in most cases, sexual assault prosecutions require the victim's cooperation, Master Deputy Jimmy Watt said in an email.

He said the agency had no records related to any allegations against the employee accused of sexually abusing John Doe. A State Law Enforcement Division spokesperson said that agency has not been involved.

The Does want to make sure cases like their son's are referred to law enforcement for thorough investigation and don't fall through the cracks. They haven't filed a report with South Carolina law enforcement because they don't trust authorities in the small, insular community to investigate, their lawyer said.

John Doe, now 18, is still mistrustful at times and it has taken years for his parents to repair their relationship with him, they said. They've talked to him about how pursuing this case could result in people finding out what happened to him, his mother said.

"He's the bravest kid I've ever met because he said, 'I don't care. This is all about helping others, Mom," she said.

# Smartmatic Lawyers Seek Discovery on 'Evasive' Recordings From Fox in Defamation Lawsuit

VOTING TECHNOLOGY COMPANY Smartmatic is asking a Manhattan judge to compel Fox to sign an affidavit swearing the company has turned over all recordings of certain company Zoom meetings that occurred around the time of the 2020 election.

The request is the latest filing in the litigation surrounding Smartmatic's \$2.7 billion lawsuit against the media conglomerate, which they've accused of airing false claims about their technology following former president Donald Trump's failed bid for a second term.

Smartmatic claims that they learned through media reports that certain zoom meetings involving defendants in the case occurred, and realized that those recordings had not been turned over as part of initial discovery.

Plaintiffs say they demanded the recordings, but Fox has since "led them on a wild goose chase"—first "stonewalling," then claiming their response was unduly burdensome, and then finally producing a single recording on the eve of a deadline set by a Judicial Hearing Officer.

The JHO then declined to issue a ruling forcing Fox to sign a *Jackson* affidavit confirming that all requested documents had been searched for and not found.

But U.K.-headquartered multinational Smartmatic-represented by Edward

Wipper, Ryan Miller, Matthew Langley, and Michael Vatis of Benesch, Friedlander, Coplan & Aronoff—says they do not trust that this is the sole recording.

"Smartmatic has only the oral representations of Fox's counsel that no other recordings exist— despite having reasons to believe that others exist and, unfortunately, being in a position where represen-

tations by Fox's counsel simply cannot be relied upon," the filing states. "Fox refuses to disclose what efforts were made as part of a purported 'investigation' to identify the existence of any others, or whether any were found."

"Fox has engaged in a pattern of conduct throughout discovery that boils down to a game of 'catch me if you can," the voting tech company said in court papers.

Plaintiffs say they have recently learned of the existence of another set of relevant recordings that were not produced, despite having been in the possession of someone who has been a custodian since the onset of document discovery.

"Despite Fox knowing about and having possession of these recordings, they were not produced," the filing states. "Fox is still 'investigating."

Defendants Fox Corp. and Fox News Network are represented by Steven Mintz and Scott Klein of Mintz & Gold and Aaron Marks and Robert W. Allen of Kirkland & Ellis.

In an order to show cause filed July 24, plaintiffs are requesting an order vacating a ruling by a judicial hearing officer denying their motion to compel a *Jackson*  affidavit and an order forcing Fox to produce a *Jackson* affidavit detailing their attempts to locate the recordings.

Smartmatic is also asking Manhattan Supreme Court Judge David B. Cohen to compel Fox to again search for recordings in their current or past possession of any conversations with custodians related to the network's coverage of the 2020 election "on or after election day."

"Smartmatic needs a *Jackson* affidavit to overcome Fox's evasiveness," the filing reads. "Smartmatic is entitled to know if such recordings existed or if they were destroyed by Fox and not preserved as they should have been. Fox must be held accountable to find and preserve evidence."

Smartmatic sued the media company as well as current and former hosts and contributors including Lou Dobbs, Maria Bartiromo, Jeanine Pirro, Rudy Giuliani and Sidney Powell in 2021, claiming defamation and disparagement.

"We will be ready to defend this case surrounding extremely newsworthy events when it goes to trial, likely in 2025," a Fox spokesperson said in a statement Wednesday. "As a report prepared by our financial expert shows, Smartmatic's damages claims are implausible, disconnected from reality, and on its face intended to chill First Amendment freedoms."

Lawyers for both sides pleaded their cases to the court during oral

arguments Thursday. Eleventh Circuit Judge Edward Carnes noted that the EPA action Hunt Refining Co. challenged also involved the agency's denial of exemption petitions from dozens of other refineries in states spanning eight federal circuits—some of which resulted in appeals that were transferred to the D.C. Circuit.

"If an EPA action-determination, whatever it is-that was being challenged affected refineries in 50 states, would you still say it was not nationally applicable?" Carnes asked.

"It's overwhelming evidence of the fact that there's nationwide application," he said.

Carnes said the company's appeal targets the analytical framework the EPA used to reach its decision on this petition and others-not the singular result for Hunt Refining. That framework is "nationally applicable" and therefore the lawsuit belongs in the D.C. Circuit, Carnes suggested.

"Analysis is action, it's decision. It's what you're challenging. You don't come in here and just challenge the end result," Carnes continued.

But Hunt Refining's attorney, Perkins Coie's Michael Huston, said the EPA

Polina Denissova, represented by Bruce and Matthew Hagen of Hagen Rosskopf, then sought wrongful death damages from the Hartsfield's estate, in addition to attorney's fees for bad faith and "for defendants being stubbornly litigious and causing [the] plaintiff unnecessary trouble and expense bringing and maintaining the lawsuit."

The trial began on July 18, with a verdict delivered in just under two hours the next day.

The pre-trial order stated that the defense objected to the plaintiffs' outline of events, though they conceded that the accident was Hartsfield's fault. The defense counsel, Anne Gower and Jason Darnielle of Gower Wooten Darneille, declined to comment and did not indicate whether they plan on appealing.

"Jason and Anne did a fantastic job, despite the difficult facts they had," Bruce Hagen said.

Bruce Hagen said the defense was "very gentle with the parents and appropriately gentle with the damages witnesses" during cross-examination. In his recollection, they asked the jury to return a \$4.5 million verdict at closing.

"I think they were just looking to get a number that was going to be less than the amount that would trigger additional attorneys fees under the settlement provision," Bruce Hagen said.

Early on, Bruce Hagen said the plaintiffs had made a policy limit demand of \$25,000 to Hartsfield's insurer, Direct General. "Direct General chose not to pay those policy limits," Bruce Hagen said. "Afterwards, it was our position that the policy limits were no longer relevant and the only thing that mattered was the full value of Andrew Evans' life."

caloosa don't want to buy renewable diesel," Huston added. "It turns on the fact that Hunt, unlike some of its larger competitors, has to ship its product through the Colonial Pipeline that doesn't accept blended fuel. ... Those are fundamentally local determinations that have to do with Hunt's individual circumstances."

In its brief, the EPA said it revised its approach to analyzing exemption petitions in response to a recent Tenth Circuit decision that the agency's prior framework violated the CAA and administrative law.

Judge Adalberto Jordan pressed the EPA on how much discretion the agency has to choose venue. He raised a 2020 Fourth Circuit case involving a West Virginia refinery in which the government had made the opposite argument: that a challenge to denial of a hardship petition should not be transferred to the D.C. Circuit.

"What has changed?" Jordan asked.

Justice Department attorney Patrick Jacobi said this case is unique in that the EPA applied the same nationally applicable framework to 30 small refineries across the country and denied the petitions within one agency action for the sake of efficiency.

And he pointed to the Eleventh Circuit's recent decision in RMS of Georgia v. EPA, where a refrigerant manufacturer challenged the EPA's allocation of fewer per-

Bruce Hagen said the parties had settlement and mediation talks that "got nowhere," and about two years before trial the plaintiffs made an \$8 million demand the defense countered with the policy limit. At closing, he said the plaintiffs asked for \$48 million, based on one of the ways their experts calculated the potential worth of the boy's life and the decision to base the number on a formula came from pre-trial focus group testing.

mits to consume hydrofluorocarbons to the company than in past years. The court held the agency's action-an "allocation notice" that detailed permits for firms nationwidewasn't locally applicable because the number of permits granted to RMS was tied to other companies' historical hydrofluorocarbon usage.

"[T]his court has accepted the idea that an agency can bundle a number of different actions," Jacobi said. "In the RMS of Georgia case, that was actually one of the points of contention of the other side, that that was not allowed. And this court found that it was."

Meanwhile, Judge Barbara Lagoa seemed skeptical that the EPA ultimately was right to deny the petition and questioned whether the agency fully took into account the refinery's individual circumstances.

"It seems to me that you're applying a theoretical ivory tower standard that has no true application to actual business costs for these small refineries," she said.

Similar suits filed by small refineries in the Third, Seventh, Ninth and Tenth Circuits were either dismissed or transferred to the D.C. Circuit, where the cases have been consolidated.

The case before the Eleventh Circuit was Hunt Refining Co. v. U.S. Environmental Protection Agency, No. 22-11617 and 22-12535. 👁

"The city has offered no specifics as to why permitting nonresident plaintiffs to gather signatures ... will cause any disruption to the political process."

Cohen said that the 60-day period for gathering signatures, which had put the deadline in mid-August, should be restarted. That means organizers will have until late September to gather the tens of thousands of signatures still needed for the proposed referendum to get on the ballot.

The effort is meant to allow voters to choose whether they want to repeal the ordinance that authorized the lease of the city-owned land upon which the project is set to be built.

As of Tuesday, organizers had gotten more than 30,000 residents to sign on to the effort, according to Paul Glaze, a spokesperson for the Vote to Stop Cop City Coalition.

Attorneys for the city and state had urged the judge to toss the entire referendum campaign, calling it "futile," and "invalid," but Cohen declined to rule on its legality, saying it was not up to him to decide that separate dispute.

"We are thrilled by Judge Cohen's ruling, and the expansion of democracy to include our DeKalb neighbors, and levels the playing field for our coalition," said Mary Hooks, a lead organizer for the coalition. "Cop City has been marred time and time again by the silencing of democratic input and repression of community participation, and since the launch of this campaign, we have been playing on a field tilted in the city of Atlanta's favor."

Asked whether officials plan to appeal the ruling, a spokesperson for Mayor Andre Dickens said officials are reviewing the judge's decision and will have more information later.

"The choice is simple," the spokesperson said in a statement. "We can either have the best-trained firefighters and police officers or we can decide to settle for sub-par training conditions in sub-par facilities."

Organizers have said they need to collect the signatures by Aug. 14 in order to make it onto the November ballot. If the signatures take longer to gather, that would push the referendum to March's ballot and potentially risk the city moving forward with constructing the facility in the meantime, though activists could seek a court order to prevent that from happening.

"We are focused on getting on the ballot, period," Glaze told the Associated Press.

Dickens and others say the \$90 million facility would replace inadequate training facilities, and would help address difficulties in hiring and retaining police officers that worsened after nationwide protests

against police brutality and racial injustice three years ago.

But opponents, who have been joined by activists from around the country, say they fear it will lead to greater militarization of the police and that its construction will exacerbate environmental damage in a poor, majority-Black area. The "Stop Cop City" effort has gone on for more than two years and at times has veered into vandalism and violence.

Organizers have modeled the referendum campaign after a successful effort in coastal Georgia, where Camden County residents voted overwhelmingly last year to block county officials from building a launchpad for blasting commercial rockets into space.

The Georgia Supreme Court in February unanimously upheld the legality of the Camden County referendum, though it remains an open question whether citizens can veto decisions of city governments.

# British Billionaire, Premier League Soccer Team Owner Arrested in NY on Insider-Trading Charges

ATTORNEYS FROM SKADDEN, Arps, Slate, Meagher & Flom have promised a vigorous defense on the part of British billionaire and Premier League soccer team owner Joseph Lewis, who has been charged along with two of his private pilots in an insider trading scheme.

Lewis, owner of Tottenham Hotspur Football Club and founder of the private equity firm Tavistock Group, pleaded not guilty Wednesday to securities fraud and conspiracy charges before U.S. Magistrate Judge Valerie Figueredo of the Southern District of New York.

Lewis' attorney, David Zornow of Skadden, called the charges "ill-conceived."

"The government has made an egregious error in judgment in charging Mr. Lewis, an 86-year-old man of impeccable integrity and prodigious accomplishment," Zornow said. "Mr. Lewis has come to the U.S. voluntarily to answer these ill-conceived charges, and we will defend him vigorously in court."

U.S. Attorney Damian Williams of the Southern District of New York said Lewis allegedly abused his access to corporate boardrooms to provide material non-public information about companies to his employees, romantic partners and friends, who then made lucrative trades.



As conditions of his release, Joseph Lewis must surrender his passport, refrain from boarding his yacht and restrict travel to a few locations, including the U.S. District Court for the Northern District of Georgia.

"None of this was necessary," Williams said. "Joe Lewis is a wealthy man, but as we allege, he used inside information as a way to compensate his employees or to shower gifts on his friends and lovers. That's classic corporate corruption. It's cheating. And it's against the law—laws that apply to everyone, no matter who you are."

Lewis was also accused of working with others to hide his ownership of shares in the pharmaceutical company Mirati Therapeutics between 2013 and 2018, in violation of U.S. Securities and Exchange Commission rules requiring that he accurately report how much of the stock he owned.

Lewis' private pilots were each charged with seven counts of securities fraud and one count of conspiracy. One pilot, Patrick O'Connor, lives in New York, while the other, Bryan "Marty" Waugh, lives in Virginia, according to prosecutors. In one instance, Lewis allegedly gave each pilot \$500,000 in short-term loans so they could buy a company's stock before it released favorable clinical results. One pilot informed a friend via text message that his "Boss is helping us out and told us to get ASAP," according to the indictment.

After pleading not guilty, Lewis was released on a \$300 million personal recognizance bond secured by his yacht, the Aviva, and his private plane. Together, the yacht and aircraft are valued at approximately \$300 million, assistant U.S. attorney Nicolas Roos said in court.

As conditions of his release, Lewis must surrender his passport, refrain from boarding his yacht and avoid international travel. His domestic travel was restricted to the Southern and Eastern Districts of New York, the Northern District of Georgia and the state of Florida, and he will be allowed to travel between those points on his private plane with advance notification to the government.

O'Connor and Waugh were each released on \$250,000 personal recognizance bonds and ordered to surrender their passports. They were also ordered to avoid piloting any aircraft.

# Legal Research Costs Could Tempt Lawyers to Turn to ChatGPT

EARLIER THIS YEAR, the legal community balked at an error that has since become a clarion call for caution when using generative artificial intelligence tools. In May, an attorney used ChatGPT for legal research and filed a brief in federal court that was rife with fake case citations the chatbot had fabricated.

The news caused an uproar, leading to sanctions for the attorney in question, and pushing some judges to require the disclosure of use of generative AI in court filings. Still, it's evident that when it comes to legal research, attorneys aren't exactly spoiled for choice.

On one end exists ChatGPT—unreliable but free, or at very low cost—while on the other end are established legal research tools, such as Thomson Reuters' Westlaw and the LexisNexis suite, which are more costly.

In the middle are several solutions, some that are included in state bar fees, and others that may be cheaper than the large legal research players, but come with limited capabilities, and often rely on Westlaw and Lexis to feed their repositories.

At the end of the day, however, many of the comprehensive options come with a high price tag, which can be a hurdle for legal professionals, so much so that some may explore riskier options.

Some attorneys told Legaltech News that while ChatGPT is most definitely not the way to go when it comes to legal research, for lawyers practicing in smaller firms with fewer resources, and solo attorneys who tend to focus in non-research heavy specialties, the online chatbot may be tempting to use, especially as costs for more traditional research tools continue to grow.

Kelly Twigger, principal at ESI Attorneys, an information law and e-discovery law firm in Colorado, and CEO of eDiscovery Assistant, said that the practical costs of legal research software differ vastly from attorney to attorney and firm to firm.

For example, while Twigger does have limited access to software that the Colorado Bar provides as a part of the annual \$500 fee, her needs extend beyond the tool's capabilities. Since she is an e-discovery attorney, Twigger requires access to state and national case law at all times, and has a subscription to another legal research tool that she pays for.

Other attorneys, however, may opt to use ChatGPT to fill their legal research gaps. Twigger believes that the costs of legal research shouldn't push someone into using the tool—but that doesn't mean they won't.

"As an attorney with ethical obligations to my clients, I'd have to do a lot of research into what those large language models actually include before I would feel even remotely comfortable, [or] even consider using it from a research perspective," Twigger said.

To be sure, not everyone feels the stickershock of legal research solutions in the same way.

Sara Perkins Jones, the president of Spark eDiscovery, has experienced the costs as a

litigator in Big Law at Ropes & Gray, and a smaller firm Anderson & Kreiger. Now, Jones is a solo practitioner who primarily focuses on e-discovery consulting.

She noted that costs for legal research software often depend on usage. For example, in Big Law, Jones said that her firm had a broad flat-rate subscription. Clients were billed for attorneys' usage and for requests that went outside the subscription.

Even so, "the law librarians would tell you: you have to limit your searches, you have to think really hard about whether you're going outside of your subscription, you have to know all these costs," Jones noted.

For Jones, in spite of those guidelines, there was far more flexibility to go beyond the subscription in Big Law. Now, as a solo practitioner, "it would be a fairly extraordinary expense," she said.

An emailed quote she received from Westlaw in October 2022 for the online digital offering including state, federal and secondary sources was \$395 per month for herself. In practice, with all the treatises and the natural language search included, a plan could reach up to \$550 monthly with secondary sources, Jones explained.

Still, Jones stressed that the repositories Westlaw and Lexis maintain are impressive and expensive to cultivate, and that she doesn't see how those costs could be lowered. But she added: "That would be certainly the most expensive subscription I have for any part of my business." To be clear, both Twigger and Jones noted that ChatGPT is not an alternative to any legal research software, and that they would not be tempted to use it regardless of the costs of more traditional solutions.

"Anyone who's actually done any significant research work doesn't find [ChatGPT] tempting," Jones said, mainly because it's a limited research tool and Google's search engine might even be a better alternative.

However, if an attorney was practicing in an arena that didn't rely on as much case law as complex litigation does—for example, small claims litigation or personal injury she could see why they might, albeit mistakenly, believe the generative AI tool is a viable cheaper option.

Indeed, Steven Schwartz, the attorney who infamously used ChatGPT to write a brief, works at Levidow, Levidow & Oberman, a firm that specialized in small claims and personal injury, she noted.

"There are areas of practice that are very trial-heavy and not very research heavy... and the iterative part of research [as an e-discovery attorney] is very difficult to do with an AI tool like ChatGPT," Jones added. "But for attorneys who focus on [trial-heavy] cases, and don't have as many resources [as Big Law], I could see these types of [AI] tools seeming like an option."

# **Recruiter Survey: Partner Exits More Often Result From Strategy, Management Miscues**

LATERAL PARTNERS ARE most often leaving law firms over disagreements about management and strategy, even more so than arguing over compensation and remote work options, new survey results show.

A lack of confidence in a firm's management or strategy was the top reason lateral partners this year said they left their firms, the 2023 Lateral Partner Satisfaction Survey from Major, Lindsey & Africa found. At the same time, the top reason partners said they chose their new firm was its perceived ability to support and elevate their practice.

Both answers were also top choices for lateral partners in 2020, when the last version of the survey was administered, analysts wrote in a 67-page summary published Thursday. They also wrote that, since the survey was first conducted nearly 27 years ago, "generations" of lateral partners have identified practice support and culture as top reasons to leave an old firm as well as to join a new one.

Management or strategy can correspond with "a host of factors," said Jon Lindsey, the New York founding partner of MLA and a co-author of the report. "For a law firm, it can be as simple as 'where we invest our money. What industries are we going after? What practices are we building up?' Or, 'how are we splitting the pie? Are we rewarding the 800pound gorillas and starving the young service partners?' How do you resolve conflict-does the bigger partner always win?"

as lateral partners in mostly Am Law 200 firms, and the survey solicited answers from more than 1,950 partners total across more than 30 practice areas and 60 cities in the United States.

A little more than 1,200 answered the question "Why did you leave your former firm?" Respondents were allowed to pick more than one among 14 possible answers, and 44% of them chose "Lack of confidence in firm management/strategy." The analysts noted that that was the No. 1 reason partners cited in 2020 for leaving their firms.

Compensation (39%), lack of support to build practice (38%), not liking the firm's culture (29%), firm's financial health (20%), lack of leadership opportunities (15%) and needing more/different offices (10%) were some of the other more popular responses.

Remote work/office attendance policies (2%) turned out to be one of the least-common answers. Lindsey and Ronald Wood, managing director in MLA's Los Angeles office and a co-author of the report, noted partners had flexibility before the pandemic, and while some firms are asking them to be in the office for training and mentoring now, they usually won't stake a major career move on remote-work guidance.

"It's not going to be a primary driver of a person's decision on where to go," Wood said. There is subtext to some of the answers, the report noted, such as the finding that

More than 1,300 respondents identified 1.4% of all lateral partners were asked to leave their firms.

> "In our experience, and as described to us by scores of firm chairs and managing partners, this is significantly lower than the probable actual figure," the report stated. "In part, the under-reporting may be attributed to the lateral partner's need to save face. Even though this was a completely anonymous and confidential survey, partners would much prefer, even in their own minds, to attribute their departure to other factors."

> For example, the report said, "If their old firm's culture was to chop partners seen as 'dead wood,' the partner could attribute their departure to culture. If a firm tells partners their compensation is to be cut by 50% as a way of forcing them out without using the words 'get out,' the partners could list compensation as the reason they left."

> In identifying the factors most important in choosing their current firm, lateral partners ranked support for their practice the highest, followed by the perception the firm was wellmanaged, then its culture and reputation.

> The more than 1,200 respondents on the question were allowed to choose one or more of 10 possible factors and rank them on a scale of 1 to 5, where 1 was least important and 5 was most important. "Practice support" garnered an average of 4.3 in terms of importance, followed by "well-managed" and "firm's culture and reputation" at 4.2.

The firm's policy on remote work/office attendance, meanwhile, scored a 1.8.

The questions about reasons for leaving an old firm and reasons for joining a new firm correspond to each other, Wood said.

"For example, if a firm has decided they really want to invest in a life sciences practice, whereas maybe a former firm thought entertainment was the way to go-you might leave one for the exact reason you're joining the other," he noted.

The answers on those questions have also been consistently identified as key reasons for lateral partner movement since 1996, when the first version of the survey was conducted, the analysts wrote.

"As lateral partner acquisitions remain the primary growth strategy for most of Big Law, the persistence of these two factors should be burrowed deep into every firm's recruiting and retention efforts," they wrote. "These factors are not gender specific, nor do they vary widely for different practice areas or levels of seniority. The extent to which a lateral partner feels and observes these factors, as they integrate into a new firm, will greatly influence how satisfied they are with the move, and whether they choose to make the firm their long-term home rather than decamp yet again."

# **Moore v. Humble** A23A0204 (6/21/2023)

Malcolm Moore appealed the denial of his motion for partial summary judgment in a case involving Diana Humble's termination of their engagement. Humble challenged the denial of her discovery motion. The court reversed the denial of Moore's motion.

Moore and Humble held themselves out as being engaged, but did not set a wedding date or execute a pre-nuptial agreement. Humble ended the engagement when she discovered that Moore had exchanged sexual messages with other women. She sued Moore for breach of promise to marry and other causes. Moore objected to her discovery requests. On Moore's motion, the court limited discovery. He filed a motion for partial summary judgment on claims for breach of promise and fraud, contending that Humble had breached the promise by breaking off the engagement and not signing a prenuptial agreement. The trial court denied both Moore's motion and Humble's separate motion to reopen discovery.

Moore appealed with contentions that the prenuptial agreement was a condition precedent and its absence renders the promise of marriage unenforceable. The court noted that a breach of a promise to marry is a common law contract action, and it agreed with Moore's contention. Although Georgia law does not favor conditions precedent, where the language of a contract creates such a condition, the condition must be enforced. Accordingly, Moore's promise to marry is unenforceable due to the parties' failure to execute a prenuptial agreement. The court also agreed with Moore's argument that his summary judgment motion on fraudulent inducement should have been granted because there is no evidence in the record to show that Moore did not intend to marry Humble. In reaching this conclusion, the court summarized the elements of a claim for fraudulent inducement and noted that Humble cannot show that Moore induced her to marry him with a present intent to deceive her at the time of their engagement. Thus, the court reversed the trial court's denial of Moore's motion for partial summary judgment on Humble's breach of contract and fraud claims. Turning next to Humble's challenges to the trial court's discovery orders, the court noted that Humble's motion to compel discovery is moot in light of its conclusions as to her breach of contract and fraud claims. As to the trial court's denial of Humble's motion to reopen discovery, the court failed to discern how reopening discovery would change any of its conclusions, which are based on matters of law. Accordingly, the court affirmed the trial court's rulings on Humble's discovery motions.

# Expert Witnesses • Medical Malpractice

# Smaha et al. v. The Medical Center of Central Georgia, Inc. A23A0267 (6/21/2023)

The defendants in a medical malpractice case appealed the disqualification of their expert witness and the grant of summary judgment in favor of The Medical Center. The court affirmed the dismissal and summary judgment order.

Marie Smaha died in 2013 following surgery at The Medical Center. Her children sued for malpractice. They attached an affidavit to their complaint from Dr. Martin Evans, as required under OCGA §24-7-702(c). Evans opined that the nurses attending to Smaha had breached the accepted standard of care. The trial court granted The Medical Center's motion to disqualify Evans on grounds that he had not supervised, taught, or instructed nurses, as required by the statute. As a result the plaintiffs were not able to establish that the nurses had breached the applicable standard of care. Smaha's children appealed the disqualification of their expert.

The court reviewed the admissibility of expert opinions under OCGA §24-7-702(c). It noted that Smaha's children had sought to establish that Evans's testimony as to the nursing standard of care was reliable within the meaning of the statute. The court noted that a physician may qualify as an expert as to non-physician health care providers if he has knowledge regarding the relevant standard of care as a result of supervising, teaching, or instructing those providers. The court reviewed how a trial court must evaluate an expert's qualifications under that exception. Evans admitted that he was not on the faculty and had not taught at a nursing school, nor had he supervised nurses at the hospital on a day-to-day basis. The court further reviewed the evidence and the trial court record and concluded that the trial court did not abuse its discretion in granting the motion to disqualify Dr. Evans as an expert on the applicable nursing standard of care. Given this holding that excluded the expert testimony, the appellants have also not shown any basis for reversing the grant of summary judgment. Accordingly, the court affirmed the trial court's ruling.

**Capote v. The State** A23A0120 (6/22/2023)

Alfredo Capote appealed the denial of his motion to dismiss a pending indictment based on the State's alleged failure to comply with the Interstate Agreement on Detainers Act (the "IAD"), OCGA §42-6-20. The court affirmed the denial.

Capote was incarcerated at a federal facility in Texas on federal wire fraud charges. He was also indicted on numerous charges in Georgia prior to his federal conviction. In December 2020, a detainer was placed on Capote under the IAD. In relevant part, the IAD provides procedures for parties incarcerated in another state to obtain a trial within 180 days of an IAD notice. On July 21, 2021, Capote filed an IAD notice and a request for disposition of the Georgia charges. No action was taken on those charges. On January 28, 2022, Capote moved to dismiss the charges for failure to dispose of them within the requisite 180 days. The State opposed the motion, claiming that neither

the district attorney nor the clerk of court had ever received Capote's IAD disposition request. At a hearing on April 22, 2022, Capote presented receipts for the mailing of the notices. The State presented evidence of its efforts to locate Capote's request. On June 8, 2022, the trial court entered an order denying Capote's motion because he presented no evidence that the mailing receipts corresponded to the documents he purportedly submitted. The trial court concluded that there was nothing to affirmatively establish that Capote had complied with Article III(b) of the IAD and no evidence to show that his request was actually received by the district attorney or clerk of court.

Capote appealed, arguing that a return receipt stamp showed delivery and created a presumption that his request had been delivered. He argued that the trial court should have relied on that presumption rather than on testimony from an investigator for the State. The court reviewed the IAD's Article III procedural requirements and disagreed that the trial court was required to find that Capote's request was delivered to the prosecuting officer and the appropriate court. The investigator's testimony is supported by at least some evidence and thus, the court could not say that the trial court clearly erred. Finding no error, the court affirmed the denial of Capote's motion.

The special concurring opinion noted that both parties presented compelling evidence, but that on motions to dismiss an indictment, the court reviews a trial court's findings for clear error.

**Williams v. The State** A23A0220 (6/21/2023)

Kelvin Williams appealed the trial court's dismissal of his motion to vacate a void sentence. The court vacated the trial court's order and remanded with instructions to deny the motion rather than to vacate it.

A jury found Williams guilty of armed robbery and other crimes in 2003. On appeal, a court reversed his conviction for kidnapping but left his other convictions and sentences intact. In 2013 and again in 2016, Williams moved to vacate a void sentence, arguing that his remaining convictions merged. The trial



court dismissed the motions and the appellate court dismissed his appeals. In 2022, Williams moved to vacate a void sentence on grounds that the State failed to provide sufficient notice of intent to rely on prior convictions to increase his sentence, and that the convictions upon which the enhancement was based were not his. The trial court dismissed the motion due to lack of jurisdiction because Williams had been sentenced within the statutory maximum sentences. Williams appealed that dismissal.

The court concluded that Williams had not shown that his sentence was void. It reviewed the guidelines and precedent that a sentencing court must follow and when an appellate court may consider a direct appeal from the denial of a motion to vacate a void sentence. It acknowledged that Williams presented a colorable void sentence claim, that the trial court had jurisdiction to review Williams's claim, and that his appeal is properly before the appellate court. Regardless, it concluded that his claim had no merit, given that his trial counsel did not object to the lack of notice of the use of alleged prior convictions. As for his claim that there is error with regard to the existence of the prior convictions used for recidivist sentencing, the court again noted that Williams's sentences fell within the prescribed statutory range. Thus, Williams cannot show that his sentence was void. The court concluded that the trial court should have denied Williams's motion rather than dismissing it, and it vacated the dismissal with instruction to deny that motion.
